The Budget Hearing of the Cuba Lake District Board of Commissioners was held on Thursday, August 8, 2002, at the Cuba Library, 39 E. Main Street, Cuba, New York. Chairperson Walt Lang called the Budget Hearing to order at 7:00 p.m. and asked the secretary to call the roll.

Commissioners Lang ,Schlifke, Laine, Sweet and Bradley were present, also in attendance were Treasurer Andy Lindquist, Attorney John M. Hart, Jr. and Secretary Pam Konieczka.

There were attendees at the Budget Hearing.

-Barb Utter, Lot #274, asked if the salary for the District Manager would come out of the Land Management Agreement Budget?

Commissioner Lang stated that the salary would come out of that budget and not the District's Budget.

Chairperson Lang submitted the Budget for 2003. The action on the Budget will take place in the regular meeting.

Chairperson Lang adjourned the Budget Hearing at 7:15 p.m.

The regular monthly meeting of the Cuba Lake District Board of Commissioners was held on Thursday, August 8, 2002, at the Cuba Library, 39 E. Main Street, Cuba, New York

Deputy Chairperson Lynn Sweet called the regular meeting to order at 7:15 p.m. and asked the secretary to call the roll:

1. Tom Swift with Clark/Patterson stated he is still gathering information in regards to the

issues of the Rawson Creek.

2. Mark McGovern stated the following results of water testing that was done on June 20 from three different sites at the Lake and on July 11. The three sites that were tested were 1) near the Yacht Club, 2) near the spillway and 3) near the Rawson Inlet before the bridge (running downstream).

Listed below are the results of that testing:

- -Mark also took 2 samples in the rawson inlet after the "spill" was reported and those results aren't in.
- -Commissioner Bradley asked if the DEC was involved after the "spill" and Commissioner Laine commented that they were.
- -Mark stated that the next water testing would be done on August 22.
- -Commissioner Laine that if because of low rainfall this season could contribute to the water quality to be better in one area than another. Mark commented that this could be a factor.

-Tom Swift commented that there may be more land needing to be acquired to create the catch

basin needed at the Rawson Creek area.

-Attorney Hart then introduced the Freeman brothers - John, Max and Stewart. They own land

located downstream from the Rawson Creek.

-Stewart Freeman stated that he and his family would like to be included on what is going on as

far as the Rawson Creek and would like to "keep the doors open of communication."

- -Discussion then ensued about the C-Slap testings that have been done in the past.
- -Tom Swift suggested doing testing near the Abbott's Creek also and comparing the results to

those of the Rawson Creek.

- -Commissioner Laine asked if Mark McGovern would be interested in finding out if the government is offering funding for more water testing. Mark stated he would be.
- -Barb Utter asked if there were problems going on with the Lake having seen several DEC

representatives around the previous week.

Commissioner Laine stated that there was a "spill" on July 31 from the Strezlec Farm. The DEC feels that there was no contamination that reached the Lake. Commissioner Laine stated that there is an accumulation at the mouth of the Rawson Creek that concerns him and feels the DEC should take care of it. The DEC stated that they don't have the resources to do so. Commissioner Sweet also spoke with another representative from the DEC, but found it very hard to communicate with him.

-Bill Dibble with Allegany Trails gave a short talk of what they are trying to accomplish and asked for the District's support.

APPROVAL OF MINUTES: Motion was made by Commissioner Schlifke to accept the minutes of the July 11, 2002 meeting, seconded by Commissioner Lang. All in favor 5 yes, 0 no.

MOTION CARRIED.

TREASURER'S REPORT: Following review of reports circulated by Treasurer, Commissioner Bradley moved to accept the Treasurer's reports for filing, seconded by Commissioner Laine. All in favor 5 yes, 0 no. MOTION CARRIED.

Treasurer Andy Lindquist stated that funds may not be available to pay the upcoming bills owed. The Commissioners passed the following resolution:

Motion made by Commissioner Lang to have the Treasurer Andy Lindquist transfer funds from the Cuba Lake District savings account to the Cuba Lake District checking account as needed to pay future bills, seconded by Commissioner Laine. All in favor 5 yes, 0 no. MOTION CARRIED.

Following presentation of the List of Claims, Commissioner Schlifke moved to pay the accounts as listed, seconded by Commissioner Bradley. All in favor 5 yes, 0 no. MOTION CARRIED.
