The Commissioners will interview in executive session the two finalists for the position, David Bosworth and Ronald Reichman.

## 2. Town of Cuba Taxes - Stipulation

It was noted a copy of the Stipulation was mailed to each cottage owner during the month of September.

#### **NEW BUSINESS:**

#### 1. Sell Trailer

Commissioner Sweet noted that two (2) offers for the trailer at Taylor Farm have been received; the highest offer was \$1,500. He noted that a sale for that price was warranted since a greater price is not likely and before long, it would cost the District to remove and junk it. Motion by Commissioner Bradley, seconded by Commissioner Schlifke to sell the trailer to John Freeman. Commissioner Sweet is authorized to execute all necessary or convenient documents to complete the transfer. All in favor: 4 yes, 0 no. MOTION CARRIED.

#### 2. Dangerous Road

The Commissioners discussed the risks of unregulated speed control along the Cuba Lake roadway, especially on the South Shore. The Commissioners instructed Attorney Hart to draft a letter for signature by the Commissioners to urge that the county and local officials in charge of enforcement and oversight give consideration to reduction in the speed limit and increased vigilance in enforcement.

## 3. Preserve Cuba Lake

Walter Lang provided a newspaper article from around 1980 which highlights the importance of Cuba Lake with the request that it be attached to the Minutes.

Motion to adjourn meeting into executive session made by Commissioner Bradley, seconded by Commissioner Schlifke at 8:50 p.m. to interview finalists for the position of Lake Manager. All in favor: 4 yes, 0 no. MOTION CARRIED.

Motion to return to regular session was made by Commissioner Schlifke, seconded by Commissioner Lang was made at 10:00 p.m. MOTION CARRIED.

A motion was entertained to employ David Bosworth as Lake Manager on a subcontract basis if possible, but in any event at a rate of \$20/hr. on a part-time basis was made by Commissioner Lang. Seconded by Commissioner Bradley. All in favor: 4 yes, 0 no. MOTION CARRIED.

The meeting was adjourned at 10:05 p.m. MOTION CARRIED.
