APPROVAL OF MINUTES: Motion was made by Commissioner Bradley to accept the minutes of the November 11, 2004 meeting, seconded by Commissioner Collins. All in favor 4 yes, 0 no. MOTION

CARRIED.

CORRECTIONS: Commissioner Bradley brought up a correction to be made under Water Quality. It should be stated:

The Town of Cuba will create a sewer district and it will be ratified by a vote by the people that live within those boundaries of the sewer district.

TREASURER'S REPORT: Following review of reports of the District Budget circulated by the Treasurer, Commissioner Laine moved to accept the Treasurer's reports for filing, seconded by Commissioner Bradley. All in favor 4 yes, 0 no. MOTION CARRIED. Following presentation of the List of Claims for the General Account, Commissioner Bradley moved to pay the accounts as listed, seconded by Commissioner Collins. All in favor 4 yes, 0 no. MOTION CARRIED.

Following review of reports of the Management Budget circulated by the Lake Manager, Dave Bosworth, Commissioner Laine moved to accept the Lake Manager's reports for filing seconded by Commissioner Bradley. All in favor 4 yes, 0 no. MOTION CARRIED.

Following presentation of the List of Claims for the Management Account, Commissioner Collins moved to pay the accounts as listed, seconded by Commissioner Bradley. All in favor 4 yes, 0 no. MOTION CARRIED.

## LAKE MANAGER'S REPORT:

Winter draw down is complete. Dave is still awaiting permission from the Seneca Nation of Indians to contract repair work on the spillway. FEMA may reimburse a percentage of the costs. Dave also spoke with Peter Sullivan (who will be contacting the Seneca Nation

of Indian's attorney) to obtain permission to repair the spillway.

We received a letter of intent from FEMA regarding eligibility for the Mount Monroe project. Dave asked for a motion to approve paying Fred Sinclaire and Colleen Cavanya from Allegany County \$20.00/hour to prepare paperwork for grant money.

Motion made by Commissioner Laine to contract Fred Sinclaire and Colleen Cavanya at a rate of \$20.00/hour to prepare paperwork for a grant to help with the costs of the Mount Monroe project not to exceed a total of \$500.00, seconded by Commissioner Collins. All in favor 4 yes, 0 no. MOTION CARRIED.

Dave is currently in the process of completing paperwork asking for reimbursement from FEMA to cover damage caused by flooding in 2004.

Dave presented a copy of a check received from FEMA in the amount of \$88,975.32 for the 2003 damages at the lake.

Dave handed out a copy of an invoice from Clark/Patterson in the amount of \$3,280.00. They stated this is for 20% of the sewer study thus far.

Dave presented copies of questions Commissioner Shemeld had on what to write in the next issue of the District Dispatch. Discussion ensued on the issues and the District Secretary will relay the information to Commissioner Shemeld.

Dave reported that the Abbotts Creek Sediment Basin/Rawson Enhanced Wetland projects are both moving slowly, but in the right direction.
