APPROVAL OF MINUTES:

Review of minutes from November 14, 2019. Comr. Bradley moved, seconded by Vice Chair Pierotti, to accept the minutes as presented. 4 yes, 0 no, Comr. Long abstained. MOTION CARRIED

TREASURER'S DISTRICT FUNDS REPORT:

Presentation of reports for the **Cuba Lake Cash Account Balances** for November 2019 was circulated by the Treasurer Lindquist.

Presentation of the **Cuba Lake District List of Claims**, \$2,955.57 for November 2019 was circulated by Treasurer Lindquist.

Comr. Long moved, seconded by Comr. Perrigo, to approve **Cuba Lake District Cash Account Balances** and **List of Claims** for November 2019. MOTION CARRIED unanimously.

TREASURER'S MANAGEMENT FUNDS REPORT:

Review of the **Cuba Lake District Management Fund Cash Balances** for November 2019 was circulated by the Treasurer Lindquist.

Presentation of the **Cuba Lake District Management Fund Checks Written Detail** in the amount of \$13,373.48 for November 2019.

Comr. Perrigo moved, seconded by Comr. Long, to approve **Cuba Lake District Management Fund Cash Balances** and **Cuba Lake District Management Fund Checks Written Detail** for November 2019. MOTION CARRIED unanimously.

CORRESPONDENCE:

1. E-mail from Jack Hart to O.G.S. in regard to possible changes to Chapter 263 of Laws of 1981. Thomas A. Phol of the O.G.S. replied to Mr. Hart stating that the agency will include the discussed legislative changes in their group of program bills. If this effort fails, he recommends that our local representative follow up. Chairman Morris will request that Mr. Hart arrange a phone call with Mr. Phol next week, or as soon as possible.

2. E-mail from O.G.S. to Jack Hart regarding the Seneca Nation of Indians.

A letter from the EPA was forwarded to the District from the Allegany County Planning Office regarding the Seneca Nation of Indians' application to the EPA for authority to regulate surface waters within its territories. Thomas A. Phol of the O.G.S. replied to Mr. Hart's inquiry on Seneca Nation application stating that the 2018 letter may have been an effort to obtain grant monies. Following some discussion, the Board will look into the matter for clarity.

3. E-mail from Jack Hart to Chairman Morris, Treasurer Lindquist, and Manager Barrey regarding the Cuba Lake District borrowing funds.

The Board discussed Chapter 263 of the Laws of 1981 in regard to the District borrowing funds to purchase the new weed harvester, and if there is a requirement to hold a public vote. The possibility of changing the wording of the law was discussed, along with updating the law to reflect today's dollar value. Several payment options for the purchase of the weed harvester were also discussed.

Comr. Perrigo moved, seconded by Comr. Long, to hold a special election (if required) within the legal time parameters for a vote on borrowing funds for the purchase of a new weed harvester. MOTION CARRIED unanimously.

Chairman Morris will follow up with counsel Jack Hart to determine if a special election is required.
