CALL TO ORDER:

The regular meeting of the Cuba Lake District Board of Commissioners was called to order by Chairman Morris at 7:04 PM.

APPROVAL OF MINUTES:

Review of the November 9, 2023 meeting minutes. Comr. Neno moved, seconded by Comr. Bradley, to accept the minutes as submitted. MOTION CARRIED unanimously.

TREASURER'S DISTRICT FUNDS REPORT:

Cuba Lake Cash Account Balances – Treasurer Lindquist provided district fund reports for both November and December. Treasurer Lindquist provided the cash fund balances for October 2023 totaling 63,969.62 and for November 2023 totaling \$59,934.10.

Cuba Lake District List of Claims – Treasurer Lindquist provided the list of claims for November 2023 totaling \$5,793.79. Treasurer Lindquist provided the list of claims for December 2023 totaling \$2,287.74.

Comr. Bradley moved, seconded by Comr. Nenno, to approve Cuba Lake District Cash Account Balances and Cuba Lake District List of Claims for November and December 2023. MOTION CARRIED unanimously.

TREASURER'S MANAGEMENT FUNDS REPORT:

Cuba Lake District Management Fund Cash Balances – Treasurer Lindquist provided Management Fund cash reports for October totaling \$139,274.66, and for November totaling \$127.354.35.

Cuba Lake District Management Fund Checks Written – Treasurer Lindquist provided the checks written for November 2023 totaling \$12,048.51, and December 2023 totaling \$11,176.50.

Comr. Bradley moved, seconded by Comr. Nenno, to approve Cuba Lake District Management Fund Cash Balances for October and November, and Cuba Lake District Management Fund Checks Written for November and December 2023. MOTION CARRIED unanimously.
